The conference will be held in a mixed format on 29 May 2025 at the Department of Political Science and Public Administration, Faculty of History, Political Science and International Relations, Yuriy Fedkovych Chernivtsi National University.

The conference aims to provide an academic discussion on topical issues in political science development and to search for new approaches and means of solving urgent problems of modern democracy in the context of security threats, geopolitical transformations, and the Russian-Ukrainian war.

The conference will include a masterclass and a presentation of educational technologies for teaching civic education in the Chernivtsi region's secondary schools and higher education institutions: "Potential of Civic Education in Countering Security Threats and Building Resilience of Ukrainian Society".

Section 1: Critical rethinking of modern political studies' conceptual and theoretical foundations: lessons from the Russian-Ukrainian war and the breakdown of the international world order.

Section II: Democratic stability of political institutions in the context of the Russian-Ukrainian war: problems, trends, and prospects.

Section III: Resistance to Russian aggression in Ukraine: institutional, informational, and public dimensions.

Section IV: Dynamics of security strategies of national states, international organisations, and integration associations in the context of creating a new format of geopolitical competition.

Section V: The system of public administration and local self-government of Ukraine: the potential for sustainability and development under the legal regime of martial law.
